# Growing ideas at fall conferences

### **DISTRICT 1**

The District 1 Fall Conference was held on Oct. 17 at the UB Center for Tomorrow. The topic was "Transgender, What Advocates Need to Know"

The speaker was Michelle Wolf, the co-chair of Spectrum, the Transgender Group of Western New York. Michelle gave an informative, insightful and heartfelt presentation regarding the history, lives and challenges of transgender people. Topics covered included definitions, history, health care, employment, the long process of transitioning and the after-effects. The program was well received by all those in attendance.

### **DISTRICT 2**

The District 2 Fall Conference was held on Oct. 17 at the First Presbyterian Church of Bath on the Square. The theme was "Women Rising out of Poverty as Entrepreneurs."

The group in attendance was very happy with the range of the speakers and their ideas. The branches took back the following ideas for their community.

Ithaca – Give Women Hope – have AAUW be a community resource to help women connect to services.

Elmira-Corning – Want to learn more from Ithaca & Cortland about how Tech Savvy works and see if it would be a viable program to run.

Fairport – Help women who can't afford formal education how to use things like EdEx and Linda.com to gain the skills they need to get a job.

Bath – Donate a copy of Marilyn Deane Mendell's book to the local library and learn more about the Jefferson County program to map existing mental health services, mentor a young woman in the community to create a business, and find out more about Access to Independence, a local organization that provides up to \$1,000 in matching funds to women to start a business.

Yates County - find out more about



how trauma affects people and choices they make.

Alfred-Hornell – Set up a meeting in Allegany County to connect small business development to the colleges' business programs with people looking to start new businesses.

GRAB (Greater Rochester) – Help the Coffee Connection to gain more visibility, push their products, and use them at branch events; perhaps assigning a business intern to work with them to further their development plans.

### **DISTRICT 3**

The District 3 Fall Conference was held on Oct. 24 at the Paleontological Research Institution and the Museum of the Earth in Ithaca. The theme was "From Mud Pies to Dinosaur Bones: Encouraging Girls' Interest in STEM."

The speakers included Warren Allmon, director of the museum, Illa Burbank, founder and president of Ithaca STEM Advocates, Ellie Fitts Fulmer – assistant professor of education at Ithaca College and past professional developer with the DaVinci Science Center, Dr. Patrice Torcivia Prusko, Instructional Designer of MOOCs and Digital Initiatives at Cornell University, Dr. Silverstone, Associate Director of the Rochester Area Colleges' Center for Excellence in Math and Science, and Sally Wolfe, professional developer for DaVinci Science Center teacher leadership programs.

# **DISTRICT 4**

The District 4 Fall Conference was held on Sept. 26 at Adirondack Commu-

nity College in Queensbury.

The program, "Food Insecurity - The Next Step," featured a panel of four speakers. Kim Cook, director of the Open Door Soup Kitchen, spoke of its varied programs, ranging from free dinners for the poor and/or homeless to backpacks of food distributed at 6 schools every weekend to identified needy children. She recommended the book "Bridges Out of Poverty" to better understand the multiple barriers faced by poor people.

Ron Hanson, chair of Bridges to Nutrition, mentioned the barriers of lack of transportation and of the high cost of fruits and vegetables.

His organization holds forums featuring the film "A Place at the Table", stages a harvest festival at a low income development, and sets up nutrition circles that coach meal planning, shopping, and cooking.

Belinda Bradley, program director of the Warren-Washington Association for Mental Health, described her work with a psychiatric day program for the mentally ill and substance abusers.

They have set up a garden and built a greenhouse at the center with the help of college and community volunteers.

The final panelist, Catherine Barton from State Senator Betty Little's office, enumerated some of the federal and state programs to help the hungry. AAUW-NYS Vice President for Public Policy Donna Seymour then spoke about her work with North Country Matters, a series of television programs focused on issues in St. Lawrence County.

Edwina Martin concluded with updates on the state Convention in Saratoga Springs.

# Guidelines for preparing a resolution for Convention

Just a quick reminder that a branch or member can submit a resolution at Convention for consideration by the delegate body.

The purpose of a resolution is to focus attention on issues of importance to the mission and vision of AAUW.

The resolution should contain specific and realistic suggestions for action.

Hint: Asking the state president to write a letter about a topic is not going to achieve sustained action.

Your first step is to carefully look at our existing Public Policy Priorities and active resolutions to see if the issue you identify is already covered at aauwnys.org

All the instructions for how to write a resolution for consideration at the NYS convention can be found on aauw-nys.org.

The 2016 deadline will be the Ides of March, March 15.

AAUW States and Branches may take positions on state or local issues that are not current AAUW priorities at the federal level, providing those issues do not conflict in any way with AAUW public policy priorities and principles.

# Race to suffrage at Convention

What a momentous event to celebrate! American citizens who were female finally obtained the right to vote in NYS in 1917. Nationally they gained the right three years later.

How are you and your branch planning to celebrate the achievement of this monumental goal? How are you going to honor the thousands of NYS women and men who worked so hard to gain women a place at the polls? What is being done to encourage everyone to celebrate the centennial of women's suffrage, that significant date when women's voices were first heard as voting citizens?

The NYS Convention Workshop "Race to Suffrage: Preparing for NYS 2017 Centennial and Looking Forward to 2020" will answer these questions and more.

NYS legislators passed a law that was signed by the governor to establish and fund a Commission for the NY Women's Suffrage Centennial.

The NY Council for the Humanities was active in the drive that resulted in the Commission becoming a reality. Sara Ogger from the Council will be telling of the Council's role on the Commission and their coordination efforts to create a statewide commemoration.

Very importantly, she will discuss the Council's grants and programs that will support this effort. With AAUW-NYS, the Commission, the Council and funding behind you, your branch will certainly have the support needed to celebrate the Centennial.

There were thousands of people in cities, towns and villages all over New York State who were committed to the cause of women's suffrage. They rallied, march, trained, went door to door and much more. Their goal was to gain women the right to vote. How can you and your branch find suffragists in your area to

honor? Bonnie Mion will share with you the many exciting ways of finding the suffragists in your area. She will also tell you stories about suffragists in the Hudson Valley. With knowledge of local people who fought for women's right to vote, you can bring the celebration to your own back yard.

2020: Project Women was created by Susan Zimet when she realized how little is known and how important the centennial is. She will be updating us on what has been happening recently.

One of Susan's first accomplishments on behalf of 2020: Project Women was to have a NYS bill passed honoring the 100th anniversary of the Spirit of 1776, one of two suffrage wagons still existing in America.

The governor proclaimed July 1, 2013 the "Spirit of 1776" Wagon Day in the state of New York. When the Commission for the NY Women's Suffrage Centennial is formed this spring she will be one of the Commissioners.

Celebrate the centennial of women achieving the right to vote. It was a major victory for women and justice. The workshop will give you the background, the tools and the knowledge to spread the word of how women gained the rights of full citizenship which we use today whenever we vote for what we believe is right.

She will be joined in the workshop by Blue Carreker, the Upstate Organizer of the NY Paid Family Leave Insurance Campaign for Citizen Action of New York, and by Christine Sadowski, the executive director of the YWCA Orange County and another WEA Steering committee member who is also a Plenary Panel member.

Our state convention follows the NYS budget process, so we have all the pieces in place to hit the ground running for the remainder of the 2016 legislative session. Be part of this great endeavor to move us forward toward real and sustained economic justice for all New Yorkers.

# AAUW-NYS proposed bylaws amendments

The following AAUW-NYS bylaws amendments were proposed by the state bylaws committee and approved by the AAUW-NYS Board of Directors at the fall board meeting Nov.13-15, 2015.

Delegates will be voting on these amendments at the AAUW-NYS Convention in Saratoga Springs, April 15-17. A copy of the AAUW-NYS Bylaws can be found on the website at "aauw-nys.org" under the "NYS Guidelines" tab.

Items below that are underlined will be removed and items in "quotations" are to be added.

Article IV

Section 3 Categories of Membership - #4 add c.

"An AAUW-NYS member is a dues paying member of both AAUW and AAUW-NYS."

Rationale – Defines a state member

#5 – a "College/University" Partner Member. ( for clarity only) Rationale – Paragraph only relates to C/U members because

next section is "other" partner members

 $Article \ V-Section \ 2$ 

The officers <u>elected</u> "nominated" in a given year shall be members of different branches. (moved from VI section 3)

Rationale – If more than one officer is nominated from the

same branch they could potentially be elected and that violates the bylaws and the intent of this article.

Article VI

Section 3 Terms of Office

No member shall hold the same office for more than two consecutive terms "unless a qualified candidate cannot be secured by February 1 of the election year."

Rationale – It is difficult to find competent officers who want to serve, it gives flexibility to the board when the situation warrants.

A term shall be defined as a year or more of a full two-year period. A period of less than one year "two years" is not to be considered when counting years of board service "or time in a specific office." The officers elected in a given year shall be members of different branches.

Rationale – If a member fills an unexpired term and is willing to serve this gives them the opportunity to serve the full two elected terms.

Article XIII

Section 2

b. voting procedures

Voting. A member of the voting body shall <u>cast no more than</u> <u>one vote.</u> "Represent no more than one vote."

Rationale – Original wording sounds like they can only vote once during the business meeting. Wording needs to indicate intent. Ie; a delegate can not hold the vote of both a branch and a state position and therefore hold two votes.
