Each District branch has chosen a project that it would like to support. Those attending are asked to bring their branch's donations to this meeting for distribution.

Buffalo Branch — will collect used books for the Annual Book Sale. Used books (no encyclopedias, Reader's Digest Condensed Books or textbooks, please). This sale raises money for scholarship awards.

Dunkirk-Fredonia Branch — will collect items for Elinor's House. This residence opened in August 2009, under the auspices of the First United Methodist Church and the efforts of Pastor Amy Fitzgerald. It provides a 'home' for women who have been released from jail, been abused or have lost their jobs and have no place to stay.

Items requested are: a twin bed, chair, hangers, toilet paper, paper towels, air freshener, shower curtain, shower curtain liner, washable bath mats, bucket, mop, rubber cleaning gloves, DVDs, an electric can opener, a tool box, vacuum cleaner, first aid kit, 4 security lock boxes, 4 alarm clocks, cleaning supplies, laundry soap, fabric softener, dryer sheets, hand soap, and non-perishable food items.

Jamestown Branch — will collect items for the YWCA of Jamestown's Transitional Housing Program. Supplies that are needed include: personal care items, sanitary products such as pads and tampons (priority need), shampoo, conditioner, body soap, deodorant, High Efficiency laundry detergent, fabric softener sheets, disinfecting wipes and non-perishable food items.

AAUW ADVOCATES – DISTRICT 1 CONFERENCE THEME

Members of the Buffalo, Dunkirk-Fredonia and Jamestown branches of the American Association of University Women met at The White Inn recently. Supporting AAUW's mission to advance equity for women and girls through advocacy, education, philanthropy and research, each branch selected an advocacy project. The Buffalo branch chose to collect books for its annual sale. Proceeds from this sale provide college scholarships for local women. The Dunkirk-Fredonia branch collected items for Elinor's House, an outreach mission of the First United Methodist Church. The Jamestown branch collected items for the YWCA's Transitional Housing Program.

Advocating for children and their families, the Honorable Judge Judith Claire described The Family Treatment Drug Court. One of the first in New York state, this court addresses families with drug problems when parents have been charged with neglecting their children. A three-stage program, The Family Treatment Drug Court is designed to halt the cycle of addiction, giving participants hope. After a year of sobriety, clients are eligible to graduate and fulfill the program goal of reuniting families.

Some of the positive aspects of this program include a decrease in the number of those charged with child neglect, a reduction in jail and prison time, a decline in the need for services and foster care. Increased employment has also been exhibited.

Now in its sixth year, The Family Treatment Drug Court has been recognized as a model court for New York State and the nation.
