Redistricting Video Series

As a follow up to the 2010 Census, a partnership was established between the St. Lawrence County AAUW Branch, the SLC League of Women Voters (LWV), and students taking Clarkson University's Comm. 310 and 427 with Dan Dullea to explore the issue of redistricting and reapportionment. A three-part video series was organized to outline the local, state and national issues in the spring of 2011 under the banner of North Country Matters, the video journal of life in the North Country, presented by the student-run WCKN's public access station at Clarkson University.

The first in the series, a Primer on Redistricting, aired on WCKN, Time Warner Cable Station 30, on Feb. 21 and 22. It featured LWV members Sue Cypert, Canton, and Miles Manchester, Potsdam, discussing the issues surrounding redistricting, using slides and information from the NYS League.

The second in the series will be taped on March 10 with Jon Montan of the SLC Planning Office, who described the process used in the county to draw county district lines following the 2000 census. This program sets the stage for looking at how the county could approach the process this time around.

Part three of the series, taped on March 24, will feature a discussion with St. Lawrence University emeritus faculty Robert Wells, a former mayor Canton, and the students in Clarkson University's Comm. 310 and 427, who will discuss the various redistricting reforms possible for 2011 in order to take the politics out of the process.

The purpose of the series is educating voters about their choices that are critical to getting a fair redistricting outcome in the public's best interest, rather than in the politician's. Using the video format means that every voter can access the material rather than limiting it to those who can attend a specific program.

An informed electorate that is represented fairly and equitably in the halls of power – no matter where they are located, is a critical component for AAUW to achieve its public policy goals. This series helps to inform voters and citizens of a fundamental building block in the public policy process-representation by elected officials is critical. Working with other community partners – and college students – is an effective way to make sure the message is heard by all and that the next generati0 is empowered.
