August 26: Celebrate the Anniversary of Women in the United States Winning the Right to Vote

On August 26, 1920, after three generations of an unrelenting, brilliant, courageous, political campaign, women in the United States won the right to vote. To honor and commemorate the historic date of the ratification of the 19th Amendment to the US Constitution, Congresswoman Bella Abzug introduced a Congressional Resolution to ensure that this date would be commemorated with the designation of Women's Equality Day, which is celebrated on August 26th each year.

6 Ballot Questions that await you in the fall

Branches have an opportunity to help educate voters on six state-wide ballot items that are up for a vote on Nov. 5. 2013 is an "off-year" election, but of course that means that there will be many important local offices on the ballot. These offices often have the most immediate effect on quality of life issues, so be sure you do your part to inform and motivate voters in your communities.

Allowing the expansion of casino gambling isn't the only constitutional issue New Yorkers will be asked to decide this November. Even though that topic has consumed

much of the attention so far, voters will also give a yea or nay to five other questions — a recent record for the number of constitutional decisions facing the state.

They range from technical tweaks to the way disabled veterans are promoted in the civil service system to how long judges should stay on the bench until retirement. And as in years past, there are questions regarding land use in the Adirondack Park.

- 1. Should veterans with combat-related disabilities get extra points when competing for civil service promotions?
- 2. Should state Supreme Court justices be allowed to stay on the bench until age 80?
- 3. Should casino gambling be allowed in the state?
- 4. Should municipalities be allowed to continue exceeding their debt limits for sewage facilities?
- 5. Should a land exchange between NYCO Minerals and the state be allowed?
- 6. Should the Legislature settle a land dispute between the state and private parties in Long Lake?

2013 AAUW Impact Grant:

AAUW-NYS received a 2013 Public Policy Impact Grant from AAUW. This \$1,000 grant will allow us to focus our attention on key topics during this next year with the help of the powerful AAUW Public Policy Department staff and resources.

The primary focus is on Title IX: Creating Safer Campus Climates, which includes sexual harassment, bullying, and gun violence. Title IX is about so much more than athletics. This effort is being coordinated by me, Jeri Fairman, our AAUW-NYS College-University Director, and Dr. Jennifer Ball, the District 7 Coordinator.

They presented a workshop at the Summer Leadership Conference in Cazenovia (the PowerPoint is available on the state website) and we'll be creating resources and how-to materials for your use.

This project is flexible, designed to work at the branch or district level. You can work with your local colleges and/or your local school system or BOCUS Center. Under the Dignity For All Student Act which went into effect last July in NYS, all schools must have a building Title IX person, as well as an overall coordinator for the district/institution.

State Tracker Program Update:

The AAUW-funded State Tracker Program will be moving into its second year, which allows us to track the status of key pieces of legislation in the NYS on a day-to-day basis during the legislative calendar. AAUW is also transitioning to the SALSA platform for

Action Network, which will allow us in NYS to write and send out our own state-based Action Alerts. AAUW-NYS receives our Salsa training on Aug. 23.

Census site offers one-stop data delivery for Congressional districts

The U.S. Census Bureau has released My Congressional District, the first interactive tool geared exclusively toward finding basic demographic and economic statistics for every congressional district in the U.S. This Web app uses the latest annual statistics from the American Community Survey, providing the most detailed portrait of America's towns and neighborhoods.

Users can sort through statistics in five key categories upon selection of a specific district in the application. Summary level statistics covering education, finance, jobs and housing, as well as basic demographic information, can quickly be displayed, downloaded and shared with others.

A major feature of the My Congressional District app is the ability to embed a selected 113th congressional district on a user's own webpage. The embedded district will display the latest statistics from the American Community Survey, allowing visitors to quickly view statistics for any of the 435 congressional districts and the District of Columbia. http://blog.timesunion.com/capitol/archives/191970/site-offers-one-stop-info-on-congressional-districts/

Victims' Dilemma: 911 Calls Can Bring Eviction

Over the last 25 years, in a trend still growing, hundreds of cities and towns across the country have adopted nuisance property or "crime-free housing" ordinances. Putting responsibility on landlords to weed out drug dealers and disruptive tenants, the laws aim to save neighborhoods from blight as well as ease burdens on the police. But the laws are sometimes forcing victims, especially women facing domestic violence, to choose between calling the police and holding on to their homes, according to legal aid groups and experts on housing and the poor.

Raise the Age NY is advocating for a comprehensive approach to raising the age of criminal responsibility in New York State. Youth in the adult criminal justice system are at high risk of victimization and abuse including physical abuse, sexual abuse, and placement in solitary confinement. Youth in adult facilities are 36 times more likely to commit suicide. Once released, youth face a lifetime of barriers associated with their criminal record. Most will be denied access to jobs and public housing. Some will face deportation depending upon their immigration status. Others will be turned away from colleges. Did you know?

- New York is one of only two states that prosecute ALL youth as adults once they turn 16 years old no matter how minor the charge?
- New York automatically charges middle school aged children as adults yes children as young as 13 - for some crimes?
- Children as young as seven can be arrested in New York?

Of the nearly 50,000 16- and 17-year-olds arrested in New York State in 2010, nearly 70% were Black or Latino. The reality becomes even starker as one moves further into the system with Black and Latino youth making up nearly 80% of youth incarcerated in 2010. The large majority of these young people are arrested for misdemeanor offenses like larceny, marijuana offenses, and criminal mischief.

New Yorkers Against Gun Violence:

Since 1992, the mission of New Yorkers Against Gun Violence (NYAGV) has been to reduce gun violence through legislative advocacy and education designed to encourage action, influence public opinion and lead to policy change. Social Security & Retirement Issues:

The average debt held by senior citizens has ballooned to \$50,000 in 2010, up 83% since 2001, according to Federal Reserve data crunched by the Employee Benefit Research Institute.

- Polaris Project Releases 2013 State Ratings on Human Trafficking Polaris Project, an organization that fights human trafficking and slavery, released its 2013 state ratings to evaluate state laws aimed at preventing human trafficking, punishing traffickers, and supporting survivors. Polaris Project identified Arkansas, Wyoming, Mississippi, and New Jersey as the most improved states in 2013
- In the News: <u>California Enacts Landmark Legislation to Protect Transgender Students' Rights</u> California is the first state to enshrine such protections in a statute and enforce them across school districts.

Education Issues:

- Head Start Releases Sequestration Cuts by State That is 3,847 children here in NYS!
- Parents Losing Jobs a Hidden Cost to Head Start Cuts While President Barack Obama advocates expanded education for all children under five, the budget deal he cut with Republicans in Congress is throwing poor children out of existing programs. The across-the-board reductions, made through a process known as sequestration, removed about \$400 million from Head Start this year, the deepest cut in dollar terms since its 1965 creation.
- Gender, Jobs and G.P.A. As early as eighth grade, girls are more likely to say they want to go to college and to earn better grades in school because of it, a new study says.

International Issues:

- Child sex tourism: 'Some girls have been married 60 times by the time they turn 18' When young girls are sold into marriage, as 38,000 are every day, they can expect a life with no education and few opportunities, little public autonomy outside of their adult husband's control and an increased risk of death from pregnancy or childbirth, which are the number one killer of girls age 15 to 18 in the developing world. One in seven girls born in the developing world is married by age 15, usually sold by her family.
- More on child brides: After a political fight, Nigeria will continue allowing them Child marriages are common in much of the developing world, where young girls sold into marriages often by poor families who need the money are less likely to finish school and more likely to die from pregnancy and childbirth complications. Many advocates consider child marriages, like prostitution or forced labor, to be a form of human trafficking.
- Providing an education for girls is global responsibility
- Family planning, higher education are priorities globally Family planning, higher education and quality time with loved ones are priorities for people around the world, according to a new global Nielsen survey of more than 29,000 people in 58 countries focusing on lifestyle values.
