## THE LEGAL ADVOCACY FUND GOALS MET

LAF had two ambitious goals this year. One was to achieve 100% participation of the New York State branches. The other was to increase the NY State contribution level to the LAF. We made both of those goals! Many thanks go to the following who made it happen:

- 53 branches, which each made a contribution
- 36 branches, which attained the LAF Star (\$3.00 or more per member)
- 37 individuals, who each contributed \$50 or more and the NYS Board members, who each gave \$25 or more

The following branches achieved the LAF Star:

The top 3 branches in contributions were

- **Islip Area** (98 members) - \$1,607.50
- **North Shore** (255 members) - \$1,277.50
- **Schenectady** (216 members) - \$1,111.00

Consequently, NY State was able to contribute \$15,276.00 to the Legal Advocacy Fund for the 1998-1999 contribution year! Congratulations to everyone who helped!

**THE LAF BREAKFAST** is now a part of the Convention packet. We were very fortunate to have Dr. Augustine Pounds, the president of the AAUW Legal Advocacy Fund, as our keynote speaker. The teal blue LAF cups on the tables at the LAF Breakfast netted \$368.25 in contributions. Thirty branches brought a total of 71 baskets for our LAF Silent Auction. \$1,950 was the grand total from the baskets! The 30 branches that brought them are well on their way to a LAF Star in 1999.

### CONGRATULATIONS to the 1999 Action for Equity Award recipients:

**Westchester Branch** received the award for their Sister-to-Sister Summit at Pace University and **St. Lawrence County Branch** for their National Girls & Women in Sports Day promotion.

The 1999 Convention in Washington, DC will be launching a new program theme for the next biennial, **Education and Equity: Choices for a Changing World**. At convention, the AAUW Educational Foundation is releasing the Sister-to-Sister and "Transitions" research. Programs on diversity, technology, and the new Woman-to-Woman program also will be presented.

The AAUW Report: *Gender Gaps: Where Schools Still Fail Our Children*, indicated that girls are severely under-represented in technology education and lack the interest and confidence boys show in this important area. In response to these findings the *AAUW Tech Check for Schools* was developed. *Tech Check* provides AAUW members and schools a tool for action to address this gender gap. This guide lists 18 indicators of a gender-equitable

learning environment, ideas on how community groups can help, and over 25 excellent resources.

## HOSPITAL MERGERS

If you attended the Issues Forum at convention or have had direct involvement with hospital mergers, you know that a variety of women's health services now available in secular hospitals (contraception, sterilization, abortion, *in vitro* fertilization, use of fetal tissue, end-of-life choices, and HIV prevention counseling) will be banned in some religious facilities. Should a merger be considered in our community, we have a wonderful resource in Lois Uttley, project director for Merger Watch. She has monitored numerous religious and secular health care partnerships throughout New York State. ## RESOLUTIONS

*A Resolution for Safe Schools*, submitted by Jeanne Riger for the Executive Committee of the Queens Branch, passed at the convention. It states that:

- AAUW branches be encouraged to make a "grassroots effort" to work for safe schools in their communities, and that
- AAUW branches be urged to make contacts with their school administrators and leaders – presidents of school boards, superintendents of schools, school principals, teacher union presidents and/or PTA presidents -- to offer volunteer participation on a citizens' committee to determine what needs to be done to make schools safer as well as to develop a process for monitoring progress.

In a **pilot program** to implement the resolution, the **Queens Branch** has formed a task force, headed by Pat Heiser (718/454-7280), to develop strategies for branch community involvement. Small grants are available in the NYS budget for other branch initiatives. Contact Kay Kraatz, NYS president, for an application (315/685-6256).

A second resolution, relating to supporting a moratorium on the death penalty, submitted by Helen Fitzgerald for the **East Hampton Branch**, did not receive the needed 2/3 vote for consideration. As a point of information, the Association passed a resolution in 1971 to abolish the death penalty; hence, this position is applicable to all states. It was suggested that individuals write the governor and

their state legislators urging their support of a moratorium on the death penalty.

## HELP BRING IMPORTANT NYS BILLS TO A VOTE:

**Clinic Access** - Call or write a brief letter to Senate Majority Leader Joseph Bruno and Codes Committee Chair Dale Volker to bring a clinic safety bill to the Senate floor for a vote. (Hon. Joseph Bruno, Room 909 LOB and Hon. Dale Volker, Room 708 LOB, NYS Senate, Albany, NY 12247 or call Sen. Bruno or Sen. Volker at 518/455-2800.)

**Women's Health and Wellness Act S2996 A**- Write to Insurance Committee Chair James Seward (307 LOB, NYS Senate, Albany, NY 12247) urging his support of the bill. The bill seeks to improve women's health in four important areas, including coverage for osteoporosis prevention and treatment, annual mammograms for women aged 40 and older, contraceptive drugs and devices, and cervical cytology screenings.

**Senior Citizen Housing S. 811** (An act to amend the real property law, in relation to the rights of senior citizens to cancel certain contracts) - Call or write Senate Majority Leader Joseph L. Bruno to bring the bill to the Senate floor for a vote. It has already passed the Assembly. The bill would allow a senior citizen to cancel a lease or contract for senior citizen housing, excluding residential health care facilities, by contacting the owner or lessor within three business days after the contract was signed.

Each one of these bills is being followed closely; memoranda in support of the Women's Health and Wellness Act and the Senior Housing Bill have been sent from NYS AAUW Public Policy to senators serving on various committees during the past year. ## 1999 PEACOCK AWARD WINNERS

The Peacock Awards encourages the New York State AAUW community to reach out to community partners and build coalitions focusing on education, equity, and diversity for women and girls. This process helps to diversify our membership and enhance our influence in NYS for the coming millennium.

### FIRST PLACE:

- **Reach Out Massapequa** was a project developed in the Human Relations Study Group that sought to initiate and participate in activities that would assist the needs of the community.
- **New York City's** four diversity programs featured a tour of Harlem, student outreach for disadvantaged girls, a forum of African-American professional women, and a program on African-American arts.
- **Westchester's Sister-to-Sister Summit** brought together 95 girls from diverse ethnic and socioeconomic backgrounds from 20 different schools.

### SECOND PLACE:

- The **Adirondack Branch** sponsored a discussion and tour of the Independent Living facility. **Syracuse Branch** led a Youth and Violence forum with the Syracuse Partnership to Reduce Juvenile Guns and Violence.
- **Schenectady** was honored for its' diversity programs that highlighted nontraditional careers for women.
