



There are those who are still trying to make it through the "glass ceiling," but most are working to make a difference for girls and women and the communities in which they live.

AAUW members are these women, shaping the future from within their communities. April's AAUW convention in Tarrytown will offer workshops from Board and branch members to help you to work to shape and change the future in your community. The coalitions that so many of our branches have formed between schools and universities, service groups, health and wellness groups, and local family centers are just a few of the ways to help change the future. All of us can do this - just replicate what another branch or its members are doing. Don't "Reinvent the Wheel" when your sisters have already done it. Just make it better!

Membership Matters:

NO STATE DUES FOR STUDENT MEMBERS

Branches that recruit undergraduate student affiliates or members who are graduate students will no longer have to collect state dues from these members. At its January meeting, the board of AAUW New York State voted unanimously to waive state dues for student members and any first-year graduates who were enrolled under the Association's "Give a Grad a Gift Program."

Kay Kraatz, AAUW New York president pointed out, "Most of these young women are or soon will be young professionals, the group that all branches need as new members to grow and thrive. Our action supports women who are pursuing higher education, often at great personal and financial sacrifice. This is our way of saying, 'AAUW believes in you.' I also encourage all branches to consider waiving local dues for student affiliates, graduate students, and first-year graduates."

Watch for Member-at-Large Lists

The **Poughkeepsie Branch** and others have been very successful at recruiting members-at-large as new branch members. Branch membership chairs should watch their mail for a packet of information, sample letter, and lists of members-at-large in their area. Registration: NYS Convention materials have been sent to all branch presidents, NYS board members, and to members who attended the conventions in 1998 and 1999. There is a \$40.00 registration fee for the convention which covers the program and all printed convention materials. The convention registration **deadline** is **March 24**. If you register after March 24, there is an additional late registration fee of \$15.00. Each person attending the convention must complete a registration form and submit payment for the total amount due. Make checks payable to **AAUW NYS Convention**.

A block of rooms has been reserved at the Hilton Tarrytown on a first come, first served basis. **Hotel reservations** must be made by **March 27, 2000.** All rooms must be guaranteed by a major credit card or by one night's deposit. Sharon's expert witness, Mary Gray, found a substantial pay equity disparity between women and men at SUNY-Buffalo. Her study was enough to move the university to



offer a settlement which Sharon accepted. Her story will inspire us with the importance of LAF.

AAUW Public Policy Action Needed in NYS in 2000

Public Policy Report: Someone once said, "We can't be more interested in blaming others; we must assume responsibility ourselves." AAUW NYS has for many years been actively involved in monitoring legislation and advocating for women in New York State. It's critical that we keep this effort going. We must be informed to impact what is happening in our New York State Legislature that has a bearing on our lives.

Pay Equity: Legislators must amend the state
Constitution and Labor Law to ensure pay equity for all
people who perform work of comparable skill, effort,
and responsibility (A.818; A. 5147; A.5031, as well as
a bill that allows women to file class action suits
charging pay discrimination - A. 1881). According to a
recent report released by the AFL-CIO and the Institute
for Women's Policy Research, a typical New York
woman brings home \$118 less per week than a man.

Hate Crime Bill: New York is one of only 11 states that have not adopted stiffer penalties for bias-related crimes. A.1573 would carry an additional maximum penalty of 15 years in the state prison for criminals that committed crimes based on race, religion, sex, nationality, disability, age or sexual orientation.

The Women's Health and Wellness Act (A.5457-B, S. 2996-B): AAUW NYS joined a coalition of more than 80 organizations to support this bill that would promote the availability of preventive health services for women. Members of AAUW NYS attended a press conference in Albany on January 18 for the reintroduction of the bill. The bill allows for coverage for early detection and treatment of osteoporosis, breast and cervical cancer screening, and ends insurer discrimination against women who are forced to assume the full costs of birth control prescriptions.

Take Action: The Senate has not acted on any of these bills. Reach your Senator by writing his/her name, NYS Senate, Albany, NY 12247 or by calling 518/455-2800.

Legislative Victories in New York State in 1999 A number of important bills were passed and signed into law in 1999. Among these were the Clinic Access and Anti-Stalking Act, the Safe Schools-Safe Children Act, the Health Care Reform Act 2000 (HCRA 2000) and Increased Child Care Funding. Thanks for all your public policy advocacy.

Connecting through Coalitions

Save Our Services - Long Island (SOS - LI) is a coalition of more than 20 organizations, including AAUW, working to protect the rights of patients and physicians affected by the pending sale of facilities to religious-based health services on Long Island.

Women's Action Coalition (WAC) of the Erie County Commission on the Status of Women includes over 100 women's agencies and organizations, including AAUW, that support women's issues. The Women's Health and Wellness Act has received the active endorsement of WAC in the past two years.

AAUW participated on a sub-committee of an 80-plus member coalition to develop a brochure to advertise the benefits of the Women's Health and Wellness Act (A.5457/S2996). The brochure will be distributed to New York legislators and the state community as a whole to generate support for the passage of this bill.

AAUW Federal Priority Issues

In 2000, several of AAUW's priority issues will continue to be under attack. Conservatives will try to overturn federal education dollars into block grants, pass private school vouchers, and roll back women's reproductive rights. While election year partisanship will make it difficult to predict what legislation will be considered in 2000, AAUW will work to advance our agenda in priority areas, including elementary and secondary education, improving access to domestic and international family planning, and managed care reform. One AAUW branch program that recognized diversity among people with disabilities received a New York State Peacock Award in 1999. Adirondack Branch members and guests met at the Center for Independent Living to investigate and to understand the broad scope of human disabilities, and to recognize the continuous effort individuals face and surmount in their lives. The Center offers its clients classes to assist in independent living. Among these are a culinary training, a program for clerical skills, physical education, and artistic classes. As a result of this evening's experience the branch made a commitment to involve themselves with the Center through volunteering, sponsoring a walk-a-thon, and enrollment in ceramics classes at the Center for Independent Living. In continuing their association with the Center the Adirondack Branch formed a partnership with the Kiwanis Club to work together to benefit the community. Congratulations!

The Americans With Disabilities Act has been instrumental in increasing accessibility in our communities. Branch meetings held in barrier-free facilities do encourage wider community participation. Day or night transportation for older members increases attendance. Awareness of religious holy days and food restrictions, lighting and a sound system, plus a welcoming committee make your branch meetings accessible and inclusive! Accessibility does not just happen! Awareness of the diverse makeup of our New York State communities will result in AAUW branches becoming a more significant presence in our neighborhoods.

Now is the time to look for program ideas for 2000-2001. **Choices for a Changing World** continues to be the program theme for Education & Equity. Why not replicate a program tried in another branch? Consult with neighboring branches about their recent successes. Here are some ideas gleaned from branch newsletters:

TRANSITIONS - How can your branch help women with educational decision making? The **Westchester Branch** is helping assist women who would like to go back to school through a new community mentoring group, TSTT (Today's Students, Tomorrow's Teachers).

SOCIAL JUSTICE - How might you bring together a diverse group of women who share similar goals? The **Mid Island Branch** held a program on elder abuse. Garden City sponsored "Seeking Solutions," to ask the question, "Can stricter gun control legislation prevent violence?"

SIGNPOSTS - How might you bring recognition to local schools for their support of equity? In the **Poughkeepsie Branch**, their *Project: Signposts* recognizes schools with exemplary programs.

TECH CHECK - How might you encourage your local schools to encourage girls to become technology competent? The **North Shore Branch** will co-sponsor their second "Women in Cyberspace" panel to hear

several women discuss their experiences in the new technological age. The **Oswego Branch** has a program to recognize 8th grade girls who excel in math & science.

SISTER-TO-SISTER SUMMITS - How might you bring together a group of girls, girls and mothers, or young men to discuss their generations challenges? Several have been held already, with several more planned for New York State in 2000.

WOMEN'S HISTORY MONTH - How are you Celebrating Women's History Month? The Buffalo Branch is holding a Women's Hall of Fame Luncheon on March 30 with a Women's Hall of Fame essay, art, web page design for high school students. In the Jamestown Branch, they are collecting biographies of high school girls...potential leaders of tomorrow.
