Much has changed in the last few years when it comes to fundraising in AAUW. Members have the opportunity to customize their AAUW giving according to their passions and priorities.

The key is in the coding. When you donate, make sure your check specifies the recipient funds by name and code.

The exciting news this year is the introduction of a brand new fund: The Carolyn Joslin Donovan International Project Grants Fund (#4377), which honors one of our own New York State leaders and her 12 years as AAUW's representative to the United Nations. The grants, which are awarded to women who have completed an AAUW International Fellowship, support community-based projects that build on the fellows' academic work and are designed to improve the social advancement and economic empowerment of women and girls in the fellows' home countries.

We hope support from NYS donors will give this fund a strong start.

At the Summer Leadership Conference in July, Nancy and Janice shared a presentation that describes all of the AAUW Funds and explains their focus. This helpful overview is posted on the AAUW Funds page of the NYS website for your reference.

Additionally, a concise guide to AAUW Funds, including NYS-based funds and fellowships, is also available. To learn about AAUW's rich history of investing in women, a link to the new video "AAUW Fellowships and Grants 125th Anniversary," is on the Funds page.

Our conference "FUN" draiser, which netted \$600, visually demonstrated the many choices members have in support of our mission and is an easy 50/50 fundraiser for a branch meeting.

Using children's sand buckets labeled with the name of each fund, we encouraged members to "shovel" their raffle tickets into the buckets that represented their greatest interests. Many thanks to our raffle winner Donna Seymour, who graciously donated her winnings to AAUW — and proved she was paying attention by carefully specifying her target funds!

Title IX is top priority among initiatives

In what I like to call the "Your AAUW Dues at Work for You Department," we have several major initiatives to report. AAUW-NYS received a 2013 Public Policy Impact Grant from AAUW. This \$1,000 grant will allow us to focus our attention on key topics during this next year with the help of the powerful AAUW Public Policy Department staff and resources.

The primary focus is on Title IX: Creating Safer Campus Climates, which includes sexual harassment, bullying, and gun violence.

Title IX is about so much more than athletics. This effort is being coordinated by me, Jeri Fairman, our AAUW-NYS College-University Director, and Dr. Jennifer Ball, the District 7 Coordinator.

Both Jeri and Jen are the Title IX Coordinators for their respective colleges, so this project will focus on making sure institutions know their responsibilities under Title IX and making sure students know their rights, as well.

They presented a workshop at the Summer Leadership Conference in Cazenovia (the PowerPoint is available on the state website) and we'll be creating resources and howto materials for your use.

This project is flexible, designed to work at the branch or district level. You can work with your local colleges and/or your local school

system or BOCES Center. Under the Dignity For All Student Act which went into effect last July in NYS, all schools must have a building Title IX person, as well as an overall coordinator for the district/institution.

Additionally, AAUW-NYS won a grant to take advantage of a special states organizer who will help us work on outreach for the Title IX (TIX) project as well as work more closely with new and existing C/U partners and help branches connect to the e-Student members at those colleges. If your branch is looking for this kind of help, please contact our C/U Director, Jeri Fairman.

The AAUW-funded State Tracker Program will be moving into its second year, which allows us to track the status of key pieces of legislation in NYS on a day-to-day basis during the legislative calendar. AAUW is also transitioning to the SALSA platform for Action Network, which will allow us in NYS to write and send out our own state-based Action Alerts.

This will come in very handy as we continue to work toward women's equality with our allies in the state legislature and our coalition partners to create a WEA-2 for 2014.

There are many issues we need to tackle to achieve true political, fiscal and employment equity for women here in the Empire State.

Thanks to AAUW, we have the tools, support and training to do just that!

AAUW's impact is felt far and wide

Greetings! Exciting things are happening in New York State.



Public Policy VP Donna Seymour applied for and was awarded an Impact Grant for New York. The other Impact Grant leaders are Jeri Fairman and Jen Ball.

The goals for the grant were as follows:

CREATING SAFER CLIMATES

- O Create campus-wide and selfawareness of Title IX rights for college students in NYS.
- O Create a climate so NYS colleges fulfill their legal and ethical obligations under Title IX.
- O Engage the approximately 75 C/U partners we have to provide Title IX education for students.

PAID SICK DAYS

- Oreate a coalition of stateorganizations to educate about the need for Paid Sick Days at the state and federal level.
- O Successfully move bills through both NY state houses to the Governor's desk for action.

New York was also one of 20 states chosen to participate in the State Organizer Pilot Program. In the application for an organizer we listed our state's top three priorities or goals for the coming fiscal year. The goals are listed below:

- 1. Increasing public policy action through the Impact Grant with a focus on Title IX and Paid Sick Leave, two issues of critical importance to women. Provide advocacy training at the state convention.
- 2. Identify and facilitate outreach to current and potential coalition partners.

Provide resource information and help to structure activities with these partners. This will help to increase AAUW's visibility in the broader community.

3. Enhance college and university partnership relationships and increase the number of partnerships. Assist branches in attracting e- student affiliates. Jeri Fairman will be our point person for the organizer pilot program.

The focus of our Summer Leadership Conference at Cazenovia was "Violence Against Women." Our speakers on the topic were Dr. David Crenshaw who spoke about abused children, Judy Lombardi who told us about battered women, Emma Condori who talked about her life in Bolivia, and Geeta Desai who spoke about partnering with women in developing countries.

We also heard from Susan Zimet

about Votes for Women 20/20 and Dr. Uma Gupta on STEM.

There were workshops on programming, fundraising and use of the national data base. Members learned about Title IX, MSK and AAUW Funds.

We all enjoyed an evening of games, chocolate, wine and face cream, as well as plenty of ice cream sundaes. Time was spent brainstorming for the 2014 Convention at Honors Haven in Ellenville on April 25 to 27.

Mark your calendars now so you can attend. Eileen Hartmann was elected to the AAUW Board of Directors and New York was well represented by our members at the National Convention in New Orleans.

Be sure to check the aauw.org website for information on the speakers and workshops at the convention.

A call for nominations

At the 2014 spring convention we will be electing three state officers for the following two years — President, Program VP and AAUW Funds VP. These officers will be working closely with branches to move our AAUW program forward throughout the state.

BRANCH ARCHIVES LINK THE PAST TO THE FUTURE

any of you have received information from previous officers or committee members for the coming year. Now is the perfect time to sort through this information and decide what should be put in your branch archives.

If you don't want the total responsibility about what to put in the archives, get together with others to go through those boxes and piles of paper.

All branch members who have accumulated branch information should also make sure this is done.

After you have saved the things you will need to perform your current job, things that can be tossed could include routine correspondence, externally created publications, old forms that are no longer in use, drafts and working copies. Notes and telephone messages that are outdated can also go into that round file.

In deciding what to save for your branch archives, think of its historical significance. Certainly founding documents, your branch bylaws and all revisions, and all your branch minutes should be included.

Past audits and budgets, publications, news clippings and press releases should be kept.

Your old directories and membership list, correspondence, including emails of a significant nature, and other branch memorabilia are all important. Photographs with names and dates and audio visual recordings help to give a human aspect to your history when saved.

Finally, scrapbooks should be included as they are a good primarily visual source of your yearly activities. Use your best judgment about what should be kept. If you are unsure, ask other branch members what they think about a particular item.

Your branch archives not only tell others about the past accomplishments of your branch, but are our gateway to the future. Information should be saved for future generations to use and enjoy. Make sure your branch is maintaining this information.
