## 3 Strategies to Retain Membership

### 1.) Have an "On Boarding Plan"

First-time members are a specific group within your membership profile and they need to be approached with specific strategies to keep them engaged. Engaged members tend to come back. Unless you can show them the value of their membership, they can slip through the cracks.

#### 2.) Say hello with a personal touch

Your first contact with the new member should come from a branch member. The personal touch is really important.

## 3.) Reach out at three months, six months, and nine months

At three months, email the newcomer with news about upcoming programs followed up by an email at six-months highlighting branch accomplishments and events. At nine months, request feedback from the new member to

gauge their participation. A short survey can be developed to capture their feedback or responses.

# Lead**HER**ship the Evvie Currie Way

Evvie Currie was a leader in the best and truest sense of the word. By deed, word and example she demonstrated what leadership is. Those of us who served with her during her years as AAUW-NYS President (2002-04) were given the rare privilege of working with a woman who "Lived the Mission" of AAUW and expected the same of us.

The 2001 state Nominating Committee in 2001 agreed that we should look for leaders with the right skills to do the jobs we had to fill that year. That meant looking outside the traditional paths to authority. As one member said, "Leadership is not a Conga line – you don't get in at the back and dance your way to the front!" Everyone agreed Evvie had the right stuff.

Every organization goes through ups and downs; times when finding leaders is especially difficult and other times when the right person appears just when she is needed. A leader with the right stuff naturally attract others who want to be in her orbit. This was true of the women Evvie Currie brought to her Board.

Evvie's previous four years as Legal Advocacy Director were a critical key to her success as state president. Because she had committed to meeting with every branch, she was the face the membership knew and the voice they trusted.

She asked each Board member to commit to travel during our time with her. She knew feeding the grassroots of advocacy takes the personal touch. Budgets are a statement of values, and Evvie budgeted the travel money we needed to fulfill her vision.



Evvie always led with a smile. She was having fun and it was fun to be with her. We proudly wore our Living the Mission T-shirts and nearly wore them out trying to keep up with her! Good fun and hard work go together, and those two years were some of the hardest fun we ever had.

Evvie was the matriarch of our AAUW-NYS family. Those of us who served with her were fortunate to spend so much time with her and were able to learn from her work ethic and example to lead. It was a wonderful two years and in many ways those were the best two years in my 40 plus years as a volunteer.

### Notes on Evvie Currie and AAUW

Evvie was a 65+ member of the American Association of University Women, a past President of the Schenectady Branch and was the Educational Foundation Named Grant Honoree of the Branch in 1997.

Evvie was the third New York State Director of the Legal Advocacy Fund. She held that position from 1998 - 2002 during which time NYS was  $2^{nd}$  in the country in contributions to the Fund every year. She was enthusiastic in educating the AAUW New York State membership to the importance of the

Legal Advocacy Fund. Evvie believed that the branches were the life-blood of AAUW and visited every single NYS branch during this time even though she was nearly 80 years old. She advocated having the LAF position become an elected Vice Presidency. The board voted to do so and in 2002 the office of NYS LAF VP was born. This allowed the position to have a place on the Executive committee.

Outreach Projects Grant was established as a national LAF grant
category by NYS to honor Evvie's commitment to the LAF. Today
funded at \$50,000, it awards grants which can be used by
colleges/universities in New York State to host campus outreach
programs that educate students on their rights pertaining to any
type of discrimination.

Evvie served as the American Association of University Women NYS President from 2002-2004. Evvie set the theme for her term at "Living the Mission" and expected each member of her Board of Directors to exemplify that theme in their home branch as well as in their board work. She was a strong, charismatic leader and people wanted to live up to her expectations. Even though she was the eldest board member and

could have treated her board members as her "kids", she treated everyone as her equal and valued each for their contributions. Every member shared the commitment to education and equity that AAUW stands for.

AAUW NYS was asked to present a workshop on "Living the Mission" at the 2003 national AAUW convention in Washington DC as an example of what could be achieved when each member is committed to the mission.

### **Evvie's Biography - Remarkable Women in New York State History**

Evelyn Meyers Currie was born on Nov. 21, 1923 in Gloversville, New York. Known to everyone as "Evvie", she led a very active and productive life. she graduated from Gloversville High School in 1941. Evvie pursued her college education at the University of Rochester and graduated with a Bachelor of Science degree in English in 1945 and followed with a Bachelor of Music in voice and Music Education at the Eastman School of Music in 1946. After graduation, Evvie marred Robert R. Currie in 1946, and since he worked for General Electric, they moved to a variety of locations including Rochester-NY, Pittsfield-MA, Scotia-NY, and Somers-NY.

Always eager to learn, Evvie continued to pursue her education as a student of Robert Shaw at Tanglewood during the summers of 1947-48. In 1966, she was awarded a masters degree in American Studies at Union college and later took graduate courses in English at Western Connecticut College in 1977.

Evvie taught vocal music and was the choral director at all levels from kindergarten through college during a 30-year span in New York State in Rochester, Schenectady, Ballston Spa, Scotia, and Somers, as well as in Detroit, Michigan.

Evvie's motto was on the calendar she kept on her desk and in her purse, "God can do tremendous things through the person who doesn't care who gets the credit!". She has spent her life in service to others. with an exceptional work ethic and ability to organize and lead others. Evvie was an invaluable contributor to a number of organizations.

Upon retirement, Evvie and her husband settled in Burnt Hills, NY, where she could pursue her interest in a variety of musical/performance opportunities in the Capital District. She was a 50-year member of the NYS School Music Association and the Music Educators National Conference. The activities related to her love for the arts included Saratoga County Arts Council, Place for Jazz, Proctor's Restored Theatre (Schenectady), League of the Schenectady Symphony Orchestra, Vice President of the Schenectady Arts Council, chair of the NYS Arts Decentralization in the Albany-Schenectady and Saratoga areas, and Saratoga Performing Arts Center (SPAC) where she was a sponsor and volunteer usher.

In addition, Evvie was involved in other community groups such as the League of Women Voters, Planned Parenthood, the Burnt Hills Methodist Church, NYS United Teachers, Sunnyview Hospital Auxiliary. She was also President of the Board of Managers of the Schenectady Day Nursery and a member of a committee of six who serve on the steering committee of the NYS Task Force

on Tobacco-free Women and Girls sponsored by Roswell Cancer Center and the NYS Dept. of Health. During the months of February and March, she and her husband worked as Elderhostel coordinators for the University of South Alabama at the Gulf Shores State Park.

Evelyn received a number of special recognitions. In 2005, she was honored with the University of Rochester's Reunion Service Award for 60 years of chairing university reunions. In 2005, she was elected to a three-year term on the Board of National Women's Hall of Fame in Seneca Falls, NY and was reelected to another three-year term in 2008. In that same year, she also received the Eastman School of Music Medallion for 62 years support of this school.

Evvie Currie's involvement with AAUW was extensive and varied. She was a Paid Life and Honorary Life members and had served in a number of capacities. At the local level in various branches in NYS and Michigan, she served as Program VP, Recording Secretary, Hospitality chair, Cultural Arts chair, LAF chair, and Executive Vice President.

\*Running & Winning – significant impact on community, opportunity for coalitions (this is an LWV program) – Westchester Branch

•Stem Workshops for Girls – Explore Your Opportunities, Tech Savvy – significant impact on community, opportunity for coalitions - Buffalo, Westchester and other branches

\*Advocacy meetings with legislators – scheduled, repeat visits – significant impact on community, opportunity for coalitions – North Shore Branch

•Diversity Brunch or Program – the Rockland County branch brings several community organizations together for coalition-building and attracts a large audience every year.

In addition, I have included two more ideas recently suggested to me:

\*Keeping Up to Date on Our Thinking re our Mission (maybe Women's Issues would be better) — ongoing programs with different members or experts talking about ideas emerging currently, e.g., Invisible Women, by Perez, on use of the default male for all statistics — opportunity to generate program ideas in branches, could be a brief session or 5 -10 minutes at frequent meetings.

•Title IX – Continuing National emphasis; this is very important and not being done at many/most schools; AAUW is an organization that can have an impact on local schools and colleges; we would need to put this workshop together for the meeting.

She was also President of the Schenectady branch from 1994-96 and was Named Grant Honoree of this branch in 1997. At the state level, she served in a number of positions to include Member of the Educational Foundation State Committee, Nominating Committee Chair, and Cultural Interests Director on the NYS AAUW Board of Directors. She was the NYS Legal Advocacy Fund Director from 1998-2002, when NYS was recognized for the second highest LAF contribution in the country, \$31,423. In 2001, she was presented a Certificate of Appreciation from the AAUW Legal Advocacy Fund Board for her commitment to the mission of LAF in the branch, state, and community. She was recognized by a special LAF fund named in her honor, "The Evvie Currie Giving Circle," to which member contributions could be designated. Evvie also served as President of AAUW NYS from 2002-04 and in 2004-05 was Advisor to the NYS President and Chair of the NYS Nominating Committee.
