
CENTENNIAL CELEBRATION

2020 Convention: Nominating Committee Report and Election Process

Dear Members of AAUW-NYS

This year there will not be a slate of officers from the Nominating Committee presented at the Convention Business Meeting. The report of the Nominating Committee, presented at the November 2019 AAUW-NYS Board meeting, was rejected due to irregularities of the process. As a result of investigation and consultations, the board agreed to accept all nominations for the positions of President, Program VP and Development VP from the floor during the business meeting at our state convention on April 25th. Any member of AAUW-NYS who is eligible to serve in the offices of President, Program Vice President and Development Vice President may be nominated from the floor at the annual meeting. Each nominee must provide written consent to serve in the office. The process will adhere to Robert's Rules of Order. Guidance will be included in the convention registration packet and will also be outlined on the website one week prior to the convention.

Eligibility requirements are:

AAUW-NYS Bylaws

Article XII. Officers

Section 2. Qualifications for Office

1. The elected and appointed officers shall be members of AAUW and AAUW-NYS. The elected and appointed directors shall facilitate and promote the purpose and mission of AAUW and AAUW-NYS. 2. Elected and appointed officers shall be chosen for their experience and work in AAUW and/or their aptitude for the duties and responsibilities of the office with due regard for geographical representation and rotation in membership.

3. No officer shall hold more than one office at a time. Section 3. Terms of Office.

c. No member shall hold the same office for more than two consecutive terms unless a qualified candidate cannot be secured by February 1 of the election year and pending approval of the executive committee. No officer may serve more than three consecutive terms in the same position.

II. Composition of the board

C. Term Limits

2. No member (elected or appointed) shall serve on the board for more than eight consecutive years except that a person who has served only one term as president, but has reached the board term limits may be permitted to be nominated for president by majority vote of the board of directors. If elected, they will also be permitted to serve as past president for one year, if they choose.

AAUW-NYS WOMEN OF CENTURY HONOREES

As part of our Centennial celebration, we are honoring five women from across New York State that has exemplified the values of AAUW. These women represents the pillars of AAUW strategic plan.



Ursula Burns

1st African American Woman CEO Fortune 500

Ursula Burns is an American businesswoman. She is the chairman and CEO of VEON, a senior advisor to Teneo, and a non-executive director of Diageo since April 2018. She is also a member of the board of directors of Uber. In 2009, Burns became CEO of Xerox, the first among black women to be a CEO of a Fortune 500 company, and the first woman to succeed another as head of a Fortune 500 company. Burns served as CEO of Xerox from 2009 to 2016 and Xerox chairwoman from 2010 to 2017. Forbes rated her the 22nd most powerful woman in the world. Among other civic positions, she was a leader of the STEM program of the White House from 2009 to 2016, and head of the President's Export Council from 2015 until 2016.

MaryEllen Elia

1st Woman Education Commissioner NYS



MaryEllen Elia is an American educator. MaryEllen Elia was born and raised in Western New York. She attended high school in Lewiston and attended Daemen College in Buffalo, where she obtained her Bachelor of Arts. She received her Master of Education and Master of Professional Studies in reading from the University at Buffalo. She served for ten years as superintendent of Hillsborough County Public Schools in Tampa, Florida, but was fired by the school board after a number of incidents that eroded the board's trust in her. Elia later served as New York State Education Commissioner. In that role she gained recognition for easing tensions surrounding implementation of the Common Core State Standards Initiative and the question of how to evaluate teachers. She provoked controversy over the removal of school aid from struggling schools, the delayed removal of an outspoken Buffalo School Board member and a directive requiring private schools to come into compliance with state standards. She resigned as education commissioner on August 31, 2019.



Hon Kathy Hochul

LT Governor NYS

Honorable Kathy Hochul is an American politician serving as Lieutenant Governor of New York since 2015. She previously served as the U.S. Representative for New York's 26th congressional district from June 1, 2011 to January 3, 2013. She prevailed in the four-candidate special election of May 24, 2011, to fill the seat left vacant by the resignation of Republican Chris Lee, and was the first Democrat to represent the district in 40 years. Hochul served as the County Clerk of Erie County, New York from 2007 until 2011, when she assumed her seat in Congress. Previously, she was a deputy county clerk, a member of the Hamburg Town Board, a practicing attorney, and a legislative aide She also worked as a government relations specialist with Buffalo-based M&T Bank. She became politically active during her college years at Syracuse University, leading a boycott of the student bookstore over high prices and an unsuccessful effort to name the university stadium after running back Ernie Davis, an alumnus, instead of the Carrier Corporation. She received her B.A. degree from Syracuse in 1980 and her law degree from the Columbus School of Law at Catholic University in Washington, D.C. in 1984.

HONOREES



Hon. Andrea Stewart-Cousins 1st Woman to lead Senate Majority NYS

Honorable Andrea Stewart-Cousins is an American politician and educator from Yonkers, New York. She represents District 35 in the New York State Senate. She serves as the body's Majority Leader and Temporary President. Stewart-Cousins is the first woman in the history of New York State to lead a conference in the New York State Legislature and is also the first female Senate Majority Leader in New York history. She was first elected to the New York State Senate in 2006. Prior to her Senate service, Stewart-Cousins was a Westchester County Legislator from 1996 to 2006. In 2012, she was chosen by her colleagues to lead the Senate Democratic Conference. After the Democratic Party won an outright Senate majority in the 2018 elections, Stewart-Cousins became Majority Leader in January 2019. Stewart-Cousins spent twenty years in the private sector, including thirteen years in sales and marketing with New York Telephone (later known as AT&T). After New York Telephone went out of business, she received a buyout and pursued a college degree while working for Gannett Newspapers. She earned her Bachelor of Science Degree from Pace University and her teaching credentials in Business Education from Lehman College. She received her Masters of Public Administration from Pace University in May 2008 and is a member of Pi Alpha Alpha, the public administration honor society.




Hon Hillary Rodham Clinton 1st Woman Senator-NYS

Honorable Hillary Rodham Clinton is an American politician, diplomat, lawyer, writer, and public speaker. She was the first woman Senator from New York State. She served as First Lady of the United States from 1993 to 2001, as a United States senator from New York from 2001 to 2009, and as the 67th United States secretary of state from 2009 until 2013. She became the first woman to be nominated for president of the United States by a major political party when she won the Democratic Party nomination in 2016.

Public Policy: Guide for Submission of a Resolution at Convention

The times that we live in call to many of us to take action on key public policy issues and initiatives locally, state-wide, and nationally.

At our April 2020 Convention the members of AAUW-NYS will review our 2020-2022 Public Policy Priorities which will focus on a few targeted areas such as passage of a NYS ERA and National ERA as well as pay equity legislation. These issues were presented and discussed by members at our AAUW-NYS Summer Leadership Conference.

We encourage members to prepare and submit a resolution to focus attention on issues of importance to the mission and vision of AAUW.

The resolution should contain specific and realistic suggestions for action. AAUW States and Branches can take positions on state or local issues that are not current AAUW priorities at the federal level, providing those issues do not conflict in any way with AAUW public policy priorities and principles.

Resolutions will be presented and discussed at the Resolutions Caucus on Friday evening and at the Business Meeting on Saturday morning. A copy of the resolution must be sent to the NYS Public Policy VP by March 20, 2020.
