#### New Report Finds Students Unaware of Loan Details, and More Women Borrowers

The Consumer Financial Protection Bureau (CFPB) recently published a report exposing data about private student loans. The report found that many students receiving private loans may not fully understand the terms of the private loans, nor do they know about cheaper federal student loan programs. An analysis of the gender dynamics of loan usage revealed that a higher proportion of women receive both private and federal loans, although the difference is small (11 percent of women vs. 10 percent of men). There is no reported difference between the proportion of men and women using only private student loans. The report concluded, unsurprisingly, that many borrowers are struggling to repay private student loans.

#### The NYS Governor's Education Reform Commission

#### School advocates gearing up for Lake Placid meeting

Members of the governor's new Education Reform Commission likely will get an earful when they travel to Lake Placid this month to hear from school officials, parents, students and other north country residents concerned about state funding for public schools and other issues. As part of a series of regional public meetings, the 20-member commission is scheduled to gather input from Northern New York from 1 to 4 pm Aug. 28 at the Lake Placid Convention Center, 2608 Main St. Tedra L. Cobb, leader of a Canton-based ad hoc group advocating for more equitable school funding, said she's been informed that only people who submit comments ahead of time will be allowed to speak that day. She's encouraging parents, students and others to submit their comments to the website: www.governor.ny.gov/webform/education. "My goal is to deluge them with comments," Ms. Cobb said. "We're concerned about the state aid formula, and we want that changed. They should be funding schools more equitably and they need to reinstate the funding that has been cut to schools. We're staying on that message." Thomas R. Burns, superintendent of St. Lawrence Board of Cooperative Educational Services, said he'll attend the session. Mr. Burns said the area's superintendents met Wednesday with state Education Commissioner John B. King Jr. Compared with other states, Mr. Burns said, New York has a poor record of equally distributing state funding for education and the situation is worsening. Making sure the state maintains its funding commitment to prekindergarten programs is another priority, Mr. Burns said. "The research is startling in terms of the benefits of prekindergarten," he said. It's important for students to participate because they're effective at explaining how budget cuts affect their education. Students may submit their comments at http://stuvoice.org. The commission has held a meeting in Binghamton and is scheduled to meet Aug. 14 at LeMoyne College, Syracuse, Established by Gov. Andrew M. Cuomo in April, the Education Reform Commission is charged with examining the structure and operation of the state's education system.

#### Want to Fix Education Policy? Ask the Students How

In suits and ties, they're spending the summer in making speeches before thousands of people, bolstering their online presence, and pushing for changes to state governance. But some of them aren't even old enough to vote. A handful of New York State high school students have banded together to create Student Voice, an organization devoted to empowering students. Their first project is to get representation on Gov. Andrew Cuomo's education reform commission, where they say students are imperative to conversations about teacher evaluations and technology policy. Two of the three students behind Student Voice come from Long Island high schools. The third, Matthew Resnick, is a senior at Manhattan's Eleanor Roosevelt High School. The organization started this spring when Malamed realized that through the internet, he could connect to

hundreds of other peers interested in education policy. That's how he met Resnick and Nikhil Goyal, a senior at Syosset High School, who helped him launch the group. In mid-May, Malamed organized a Twitter chat with the hashtag #StuVoice. He expected 10 or 15 students to participate, but the numbers were much larger, he said, and adults joined in as well. The experience made Malamed realize that students needed a central outlet to share their ideas about education, and their stories from the ground, and <u>StuVoice.org</u> was born. The site formally launched on Tuesday with short essays from high school and college students from across the country. In the meantime, he began to collaborate with Resnick and Goyal on Student Voice's big project — getting student representation on the New York Education Reform Commission. After the trio sent a letter to Cuomo making their case, the governor responded with a letter that said the commission had already capped out at 25 members but encouraged the students to show up at hearings. Malamed said he was happy just to get a response.

#### Is Social Security still a good deal for workers?

Social Security is old age, survivors, and disability insurance. Social Security is not just a retirement savings program. In New York State, on average, there are more than 3 million people receiving Social Security benefits. Nationally, on average, in any month, SS insurance benefits go to:

- 4.3 million children Average benefit: \$564
- 8.7 million disabled workers. Average benefit: \$1,111.
- 4.4 million widows and widowers. Average survivor's benefit: \$1,152.

Without Social Security, single women who work in low-wage positions would have to save 25% of their earnings starting from their first day of work in order to adequately provide for retirement. Over half of all elderly women would be poor without Social Security. Estimates show that the poverty rate for individuals age 65 and older would increase from 10% to nearly 50% without Social Security benefits. According to the Institute for Women's Policy Research, in 2005, more than two-thirds of unmarried women would be living below the poverty line if they did not receive Social Security.

Social Security matters a great deal to the 46% of senior citizens in the United States who have less than \$10,000 in financial assets when they die. Most of these people rely almost totally on Social Security payments as their only formal means of support. **Study: Many Americans die with 'virtually no financial assets**' http://phys.org/news/2012-08-americans-die-virtually-financial-assets.html

#### Issue: America's Children

#### The State of America's Children 2012

- There are 16.4 million poor children in rich America, 7.4 million living in extreme poverty.
- A majority of public school students and more than three out of four Black and Hispanic children, who will be a majority of our child population by 2019, are unable to read or compute at grade level in the fourth or eighth grade and will be unprepared to succeed in our increasingly competitive global economy.
- Nearly eight million children are uninsured.
- More children were killed by guns in 2008-2009 than U.S. military personnel in both the Iraq and Afghanistan wars to date.

Millions of children are living hopeless, poverty- and violence-stricken lives in the war zones of our cities; in the educational deserts of our rural areas; in the moral deserts of our corrosive culture that saturates them with violent, materialistic, and individualistic messages; and in the leadership deserts of our political and economic life where greed and self interest trump the common good over and over.

Millions of our children are being left behind without the most basic human supports they need to survive and thrive when parents alone cannot provide for them at a time of deep economic downturn, joblessness, and low wage jobs that place a ceiling on economic mobility for millions as America's dream dims.

Unemployment, underemployment, and economic inequality are rife and will worsen if massive cascading federal, state, and local budget cuts aimed primarily at the poor and young succeed. Homeless shelters, child hunger, and child suffering have become normalized in the richest nation on earth. It's time to reset our moral compass and redefine how we measure success.

The Children's Defense Fund has just released The State of America's Children® 2012 Handbook. This report is a portrait of where our children are right now and a tool to spur us to set the vision of where we need to go to stop the downward mobility of our children and grandchildren and the diminution of America's future. #### Issue: Paid Sick Leave

#### Workers with paid sick leave are healthier

U.S. workers with access to paid sick leave are 28 percent less likely than those without sick leave to suffer non-fatal work-related injuries, officials say. Researchers at the Centers for Disease Control and Prevention's National Institute for Occupational Safety and Health analyzed data from 2005 to 2008 collected by the National Health Interview Survey. The study considered 38,000 private sector workers only because most full-time public sector workers have access to paid sick leave, the researchers said. The study found workers in high-risk occupations, and industry sectors such as construction, manufacturing, agriculture and healthcare and social assistance, appeared to benefit most from access to paid sick leave.

## How under-26 workers choose health insurance — their own, or their parents'

Young adults who need health insurance have more options than before under the health-care overhaul, which generally allows them to stay on their parents' plans until they reach age 26. But the provision gives employers new options, too: They can encourage their young employees to join Mom and Dad's plan rather than sign up for the company policy. Although experts say the practice is uncommon, some think more employers may consider this approach in the future. http://tinyurl.com/cw7f2fu

#### Parents' insurance covers children up to age 26 — but not for pregnancy

The health-care overhaul provides a safety net for young adult children, who can now stay on their parents' health plans until they reach age 26. But it doesn't guarantee that their parents' plan will cover a common medical condition that many young women face: pregnancy. Group health plans with 15 or more workers are required to provide maternity benefits for employees and their spouses under the <u>Pregnancy Discrimination</u> <u>Act of 1978.</u> But other dependents of employees aren't covered by the law, so companies don't have to provide maternity coverage for them.

- Insurance companies no longer have unchecked power to cancel your policy, deny you coverage, or charge women more than men.
- Americans will never again be denied care or charged more due to a pre-existing condition, like cancer or even asthma.
- Preventive care will be covered free of charge by insurance companies--including mammograms for women and wellness visits for seniors.
- Millions of Americans will receive a rebate because their insurance company spent too much of their premium on administrative costs or CEO bonuses.
- Insurance companies will be required to provide health-benefit information to consumers in plain, understandable language AKA no more loopholes and fine print.

#### **Preventive Services Covered Under the Affordable Care Act**

If you have a new health insurance plan or insurance policy beginning on or after September 23, 2010, the following preventive services must be covered without your having to pay a copayment or co-insurance or meet your deductible. #### **Dense Breast Notification is Law in NYS**

The fight against breast cancer in New York took a big step forward with Breast Density Inform legislation, sponsored by Senator John Flanagan and Assemblywoman Ellen Jaffee. The vast majority of women are unaware of the impact dense tissue has on the likelihood they will get cancer and many are completely unaware of their own density and therefore unaware of their own elevated risk for breast cancer. The law takes effect in 180 days.

Mammograms miss 40% of breast cancers in women with dense breast tissue, and such women are four times more likely to develop breast cancer than others. A campaign dubbed "Are You Dense?" is gaining momentum. Read more at:
